Additionally, CARES will use the After Action Report format for documenting training drills and exercises.

1. Introduction and Background

The Cupertino Amateur Radio Emergency Service (CARES) participated in the annual Cupertino Lunar New Year Parade as hosted by 2005 Lunar New Year Unity Parade & International Fair Committee, an ad hoc committee of Cupertino residents interested in promoting the diversity of Cupertino. From a CARES perspective, the purpose of this exercise was to (i) Provide communications support to the parade coordinators as needed, and (ii) Support the CERT organization in providing communications for their First Aid teams during the parade.

On 12-March, the City initiated a Training Activation under the designation CUP-05-03T.

This report covers the activities undertaken by responding volunteers in support of this event.

3. Description of Event / Drill / Exercise

This is the 3rd year that CARES has participated in this event. While most of the event organizers rely on Cell Phone and FRS where usable, the role of CARES has been to provide communications support for CERTs' First Aid teams, logistical support for County Sheriff, and ad hoc support to parade participants at Staging, along the parade route, and the Destaging area.

The parade route covers about a 1.2 mile area along Stelling Road from Jollyman Park to Memorial Park. CARES and CERT members assembled at the parking lot of St Judes Episcopal Church, corner of Stelling Road and McClellan Road.

During the event, CARES resources were dispatched into the following field locations:

- 1. Net control station
- 2. First Aid. 2 teams
- 3. Parade Staging area
- 4. Rover along Stelling, 2 individuals
- 5. De-Staging

CARES and CERT members were teamed up into First Aid Teams and provided event support at the Staging location and along the parade route.

All communications was handled within an open net using CARES TAC-3 (K6FUZ repeater, 147.105+). FRS Radio checks were performed, but with limited success given the coverage and extent of the event area.

Event resources were provided from the following organizations:

- 1. Cupertino ARES/RACES: Responsible for staffing all communications positions. No EOC activation was required. Nine CARES members participated.
- 3. Cupertino CERT: Responsible for staffing and providing all First Aid positions. About 6 CERT members participated in this event.

All events took place on Saturday, 13-Nov-04. All times listed are in local time.

Overall, the event appeared to have proceeded smoothly. The elimination of the performance in front of the reviewing stand ensured a continuous flow of parade units.

What worked?

- Good net control and discipline
- Participating in the briefing at the beginning of the event.
- Good coordination with the Sheriffs Office.
- Good linkage between CERT and CARES.

What needs improvement?

- Event coordinators appeared to have left staging toward the end of the parade. Several people were still looking for information about logistics. CARES and CERT addressed as best possible.
- Regarding the people count: Need to start earlier if the parade is going to move as fast as it did. Require 2 individuals to cover this assignment.

Recommendation

Need to communicate the nature of the event earlier than we did to ensure an adequate CARES turnout.
