

# Exercise Scenario

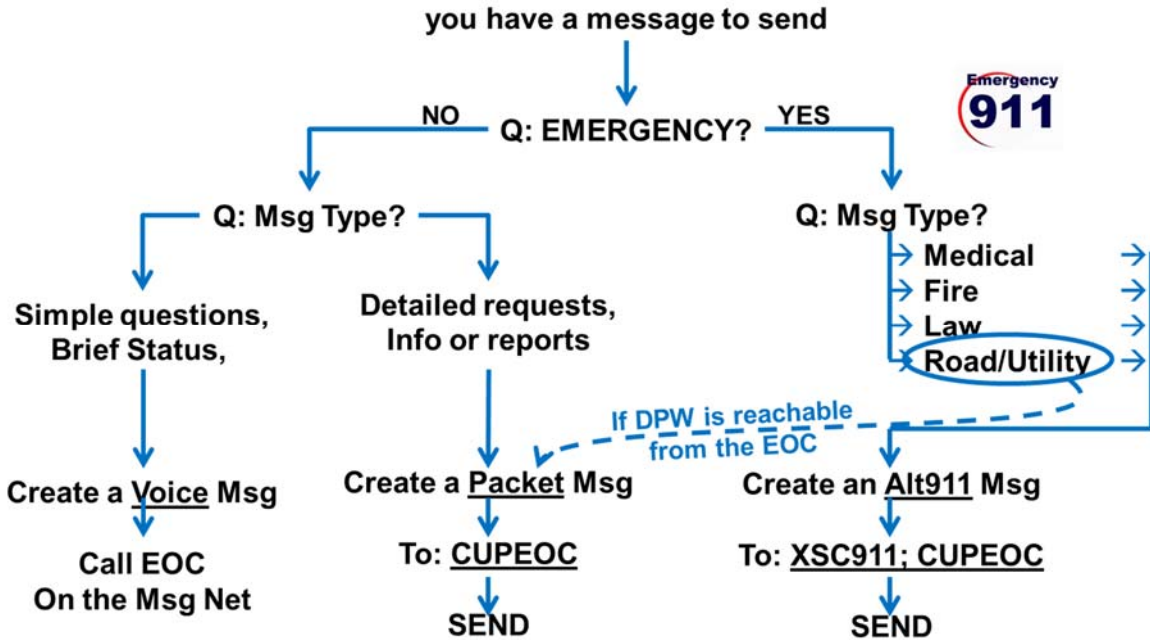
The following is provided as general information for your consideration during this drill.

Location	Cupertino ARK location:
General Situation	<p>A major earthquake occurs along the San Andreas Fault, rupturing approximately 300 miles of the northern segment of the fault, from the San Juan Bautista area in the south to Cape Mendocino in the north. The epicenter is west of the Golden Gate Bridge. The main shock lasts 45 to 60 seconds and was preceded by a foreshock of 20 to 25 seconds. There was no other warning. Shaking is felt in Oregon to the north, Los Angeles to the south, and Nevada to the east.</p> <p>The estimated magnitude is M 7.9 with reports of (Modified Mercalli Intensity, MMI VIII) severe to violent shaking with heavy damage in widespread areas of the most severely affected counties. Pockets in the affected counties experience extreme shaking and very heavy damage, particularly areas immediately adjacent to the fault and areas where liquefaction occurred.</p>
Weather:	Weather is current conditions at the time of the drill

## INSTRUCTIONS:

You will be presented with reports that come to you either from the community or from your own observations (both simulated). Determine the following:

1. Is this information to be passed going to the EOC or some other location?
2. If Yes,
  - a. What is the nature of the report: the urgency, and who should receive it.
  - b. For messages that look like an emergency request for FIRE, an AMBULANCE, or the SHERIFF that would normally go by 9-1-1, use Packet with Alt911. Send these messages to **XSC911; CUPEOC**.
  - c. For messages that are Public Works related and is something the City would handle (local road closures, trees down, etc.), send these messages to **CUPEOC**.
  - d. Voice traffic may be appropriate for messages to the EOC that are lower priority, or brief reports or updates.
3. Use your best judgement when choosing the method and destination to send the message.



4. Read each item as if someone was coming to you and telling you their problem.
5. Feel free to switch roles: CERT as the simulated resident coming to CARES as the ALT911 Call Taker. Then, swap positions and CERT is the ALT911 Call Taker (some minor OJT may be needed) and CARES is the simulated resident.
6. For “Last seen?”. Enter the time as 2 and 10 minutes prior to now.
7. There are 25 messages to pass. You may not get through all of them. Assuming 2.5 hours for message passing, that’s about one message every 6 minutes. This is not a contest to get them all done quickly, but to get them done thoughtfully.
8. Start with Message #1 now!
